

WEBSITE TERMS AND CONDITIONS OF USE

1. About the Website

1. 1. Welcome to www.anzcen.edu.au (the '**Website**'). The Website Australian & New Zealand College of Emergency Nurses (the '**Services**').
1. 2. The Website is operated by Australian & New Zealand College of Emergency Nurses. Access to and use of the Website, or any of its associated Products or Services, is provided by Australian & New Zealand College of Emergency Nurses. Please read these terms and conditions (the '**Terms**') carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.
1. 3. Australian & New Zealand College of Emergency Nurses reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Australian & New Zealand College of Emergency Nurses updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

2. Acceptance of the Terms

You accept the Terms by remaining on the Website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Australian & New Zealand College of Emergency Nurses in the user interface.

3. Subscription to use the Services

3. 1. In order to access the Services, you must first purchase a subscription through the Website (the '**Subscription**') and pay the applicable fee for the selected Subscription (the '**Subscription Fee**').
3. 2. In purchasing the Subscription, you acknowledge and agree that it is your responsibility to ensure that the Subscription you elect to purchase is suitable for your use.
3. 3. Once you have purchased the Subscription, you will then be required to register for an account through the Website before you can access the Services (the '**Account**').
3. 4. As part of the registration process, or as part of your continued use of the Services, you may be required to provide personal information about yourself (such as identification or contact details), including:
 - (a) Email address
 - (b) Preferred username
 - (c) Mailing address
 - (d) Telephone number

(e) Password

3. 5. You warrant that any information you give to Australian & New Zealand College of Emergency Nurses in the course of completing the registration process will always be accurate, correct and up to date.

3. 6. Once you have completed the registration process, you will be a registered member of the Website ('**Member**') and agree to be bound by the Terms. As a Member you will be granted immediate access to the Services from the time you have completed the registration process until the subscription period expires (the '**Subscription Period**').

3. 7. You may not use the Services and may not accept the Terms if:

- (a) you are not of legal age to form a binding contract with Australian & New Zealand College of Emergency Nurses; or
- (b) you are a person barred from receiving the Services under the laws of Australia or other countries including the country in which you are resident or from which you use the Services.

4. **Your obligations as a Member**

4. 1. As a Member, you agree to comply with the following:

- (a) you will use the Services only for purposes that are permitted by:
 - (i) the Terms; and
 - (ii) any applicable law, regulation or generally accepted practices or guidelines in the relevant jurisdictions;
- (b) you have the sole responsibility for protecting the confidentiality of your password and/or email address. Use of your password by any other person may result in the immediate cancellation of the Services;
- (c) any use of your registration information by any other person, or third parties, is strictly prohibited. You agree to immediately notify Australian & New Zealand College of Emergency Nurses of any unauthorised use of your password or email address or any breach of security of which you have become aware;
- (d) access and use of the Website is limited, non-transferable and allows for the sole use of the Website by you for the purposes of Australian & New Zealand College of Emergency Nurses providing the Services;
- (e) you will not use the Services or the Website in connection with any commercial endeavours except those that are specifically endorsed or approved by the management of Australian & New Zealand College of Emergency Nurses;

- (g) you agree that commercial advertisements, affiliate links, and other forms of solicitation may be removed from the Website without notice and may result in termination of the Services. Appropriate legal action will be taken by Australian & New Zealand College of Emergency Nurses for any illegal

5. Payment

5. 1.Where the option is given to you, you may make payment of the Subscription Fee by way of:

5. 2.All payments made in the course of your use of the Services are made using Stripe. In using the Website, the Services or when making any payment in relation to your use of the Services, you warrant that you have read, understood and agree to be bound by the Stripe terms and conditions which are available on their website.

5. 3.You acknowledge and agree that where a request for the payment of the Subscription Fee is returned or denied, for whatever reason, by your financial institution or is unpaid by you for any other reason, then you are liable for any costs, including banking fees and charges, associated with the Subscription Fee .

5. 4.You agree and acknowledge that Australian & New Zealand College of Emergency Nurses can vary the Subscription Fee at any time and that the varied Subscription Fee will come into effect following the conclusion of the existing Subscription Period.

6. Refund Policy

Australian & New Zealand College of Emergency Nurses will only provide you with a refund of the Subscription Fee in the event they are unable to continue to provide the Services or if the manager of Australian & New Zealand College of Emergency Nurses makes a decision, at its absolute discretion, that it is reasonable to do so under the circumstances . Where this occurs, the refund will be in the proportional amount of the Subscription Fee that remains unused by the Member (the '**Refund**').

- (a) use the Website pursuant to the Terms;

Australian & New Zealand College of Emergency Nurses does not grant you any other rights whatsoever in relation to the Website or the Services. All other rights are expressly reserved by Australian & New Zealand College of Emergency Nurses.

7. 3. Australian & New Zealand College of Emergency Nurses retains all rights, title and interest in and to the Website and all related Services. Nothing you do on or in relation to the Website will transfer any:

You may not, without the prior written permission of Australian & New Zealand College of Emergency Nurses and the permission of any other relevant rights owners: broadcast, republish, up-load to a third party, transmit, post, distribute, show or play in public, adapt or change in any way the Services or third party Services for any purpose, unless otherwise provided by these Terms. This prohibition does not extend to materials on the Website, which are freely available for re-use or are in the public domain.

8. Privacy

8. 1. Australian & New Zealand College of Emergency Nurses takes your privacy seriously and any information provided through your use of the Website and/or Services are subject to Australian & New Zealand College of Emergency Nurses's Privacy Policy, which is available on the Website.

9. General Disclaimer

9. 1. Nothing in the Terms limits or excludes any guarantees, warranties, representations or conditions implied or imposed by law, including the Australian Consumer Law (or any liability under them) which by law may not be limited or excluded.

9. 2. Subject to this clause, and to the extent permitted by law:

- (a) all terms, guarantees, warranties, representations or conditions which are not expressly stated in the Terms are excluded; and
- (b) Australian & New Zealand College of Emergency Nurses will not be liable for any special, indirect or consequential loss or damage (unless such loss

or damage is reasonably foreseeable resulting from our failure to meet an applicable Consumer Guarantee), loss of profit or opportunity, or damage to goodwill arising out of or in connection with the Services or these Terms (including as a result of not being able to use the Services or the late supply of the Services), whether at common law, under contract, tort (including negligence), in equity, pursuant to statute or otherwise.

9. 3. Use of the Website and the Services is at your own risk. Everything on the Website and the Services is provided to you "as is" and "as available" without warranty or condition of any kind. 11. 1. 11. 2. You expressly understand and agree that Australian & New Zealand College of Emergency Nurses, its affiliates, employees, agents, contributors and licensors shall not be liable to you for any direct, indirect, incidental, special consequential or exemplary damages which may be incurred by you, however caused and under any theory of liability. This shall include, but is not limited to, any loss of profit (whether incurred directly or indirectly), any loss of goodwill or business reputation and any other intangible loss.

12. Termination of Contract

12. 1. The Terms will continue to apply until terminated by either you or by Australian & New Zealand College of Emergency Nurses as set out below.
12. 2. If you want to terminate the Terms, you may do so by:
 - (a) not renewing the Subscription prior to the end of the Subscription Period;
 - (b) providing Australian & New Zealand College of Emergency Nurses with 1 days' notice of your intention to terminate; and
 - (c) closing your accounts for all of the services which you use, where Australian & New Zealand College of Emergency Nurses has made this option available to you.

Your notice should be sent, in writing, to Australian & New Zealand College of Emergency Nurses via the 'Contact Us' link on our homepage.

12. 3. Australian & New Zealand College of Emergency Nurses may at any time, terminate the Terms with you if:
 - (a) you do not renew the Subscription at the end of the Subscription Period;
 - (b) you have breached any provision of the Terms or intend to breach any provision;
 - (c) Australian & New Zealand College of Emergency Nurses is required to do so by law;
 - (d) the provision of the Services to you by Australian & New Zealand College of Emergency Nurses is, in the opinion of Australian & New Zealand College of Emergency Nurses, no longer commercially viable.
12. 4. Subject to local applicable laws, Australian & New Zealand College of Emergency Nurses reserves the right to discontinue or cancel your membership at any time and may suspend or deny, in its sole discretion, your access to all or any portion of the Website or the Services without notice if you breach any provision of the Terms or any applicable law or if your conduct impacts Australian & New Zealand College of Emergency Nurses's name or reputation or violates the rights of those of another party.

13. Indemnity

- (a) all actions, suits, claims, demands, liabilities, costs, expenses, loss and damage (including legal fees on a full indemnity basis) incurred, suffered or arising out of or in connection with Your Content;
- (b) any direct or indirect consequences of you accessing, using or transacting on the Website or attempts to do so; and/or
- (c) any breach of the Terms.

14. Venue and Jurisdiction

The Services offered by Australian & New Zealand College of Emergency Nurses is intended to be viewed by residents of Australia. In the event of any dispute arising out of or in relation to the Website, you agree that the exclusive venue for resolving any dispute shall be in the courts of Australia Capital Territory, Australia.

15. Governing Law

The Terms are governed by the laws of Australia Capital Territory, Australia. Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of Australia Capital Territory, Australia, without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clause is not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.

16. Independent Legal Advice

Both parties confirm and declare that the provisions of the Terms are fair and reasonable and both parties having taken the opportunity to obtain independent legal advice and declare the Terms are not against public policy on the grounds of inequality or bargaining power or general grounds of restraint of trade.

17. Severance

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
